CASE MANAGEMENT (CM)

Case management services involve a collaborative process of assessment, planning, facilitation, care coordination, monitoring, evaluation, and advocacy for options to meet the client and family's comprehensive health needs through communication and resources to promote client safety, quality of care and cost-effective outcomes. Services include catastrophic management, telephonic, field and task assignments with medication reconciliation conducted with the medical team and other participants as needed.

LEGAL NURSE CONSULTANT (LNC) The LNC screen cases for merit, assist with discovery; conduct extensive literature and medical research; review medical records; identify standards of care; prepare reports and summaries on the extent of injury or illness; create demonstrative evidence, and locate or act as expert witnesses. The LCP report is a comprehensive, systematic method of determining an individual care needs and related costs using a step-by-step procedure and methodology in developing a plan throughout life expectancy.

MEDICAL COST PROJECTIONS (MCP)

The MCP report is a valuable tool utilized when setting reserves, determining settlement exposure or deciding the best time to settle a case. Our MCP reports include a comprehensive analysis of the file based on jurisdictional requirements, current or specific treatment guidelines, all relevant and medical reports obtained from all treating sources, payment history, and prescription drug cost associated with an injury or illness.

MEDICARE SET-ASIDE ALLOCATION (MSA) The MSA provides a tool for the settlement of a workers' compensation or liability injury case. An MSA includes a detailed report delineating future medical expenses related to a work-related or personal injury case. The report indicates anticipated future Medicare covered expenses for the remainder of the client's life expectancy. The report provides the settling parties with a dollar amount that should be "set aside" out of the settlement funds to satisfy Medicare's future interests.
